The multi-stakeholder approach has been of key value to our work so far in defining *access* and assessing patient and other stakeholders' experiences of access across the EU. More specifically, it has been used for designing and conducting a questionnaire based on the 5As principles of access to evaluate elements of healthcare systems such as primary care, hospital care, medicines, etc. and thereby provide practical tools for future policy action.

Moreover, PACT received additional attention, recognition and support at the European Health Forum in Gastein during the session that we organised with a focus on multi-morbidity as one of the fundamental issues for the sustainability of healthcare systems across the EU.

We also take pride and are grateful for the active engagement of the MEP Interest group on access whose members tirelessly explore opportunities for expanding the support in the European Parliament. The MEP Interest Group will organise an event which will take place in November. We will be delighted to see you all there and will be in touch with more information soon.

The Commission's Expert Panel on Access to Healthcare was published last month. It reiterates the importance of working in partnership to galvanise our common efforts and find **solutions** that will improve access to quality healthcare in Europe.

The Patient Access Partnership will do what it can to support this process.

### **Open Consultation - Preliminary opinion from the Expert Panel on Effective Ways of Investing in Health – Deadline for comments Friday 6 November**

The **Expert Panel on Effective ways of investing in health** has published the Preliminary Opinion on access to health services in the European Union.

The Preliminary Opinion addresses barriers to accessing health care and explores policy measures to overcome them. Ways to improve equity could include matching health needs and financial resources, affordable and accessible health services, the availability of a sufficient number of health workers with the right skills, well-equipped facilities within easy reach, the availability of quality medicines and medical devices and services that are relevant and cost-effective. It pays special attention to access to health services for underserved groups as Roma, undocumented migrants and people with mental health problems.

The Expert Panel is seeking feedback on this preliminary Opinion, and the European Commission has launched a public consultation, until November 6<sup>th</sup>.

All interested parties can submit their comments, which will enable the expert panel to formulate its final views.

PACT strongly encourage its partners to engage in the consultation process, and submit their written comments following the procedure established in the Consultation, before **Friday 6 November**.
